



The Comix Method Terms and Conditions

It is recommended that you read this in full before registering or subscribing.

1. Program Overview

Enrollment in The Comix Method Certification Program provides participants with access to the certification course, training materials, instructional videos, downloadable resources, and certification opportunities designed to support the professional development of dance educators.

Subscriptions to The Comix Method: Resources grant access to all instructional videos, downloadable materials, and additional resources available through the Resources program.

2. The Comix Method's Payment Options

Comix Method: Certification

- Studio Unlimited Access: Pay the full tuition of \$1,799 USD, or select the 12-month payment plan, billed in 12 consecutive monthly installments at a slightly higher total amount.
- Individual Access: Pay the full tuition of \$699 USD, or select the 12-month payment plan, billed in 12 consecutive monthly installments at a higher total amount.

Comix Method Resources

- Monthly Access: \$39 per month, billed automatically each month.
- Annual Access: \$399 per year, billed annually (save \$70).
- Studio Unlimited Access: \$799 annual payment, granting studio-wide access to all resources.
- Certified Comix Method educators receive a 50% discount on all monthly or annual options.

3. Payment Commitment

By choosing a certification payment plan, you agree to complete all 12 monthly payments in full. The payment plan is non-cancelable and non-refundable once initiated, as it represents a commitment to the full cost of the certification program.

Monthly and annual subscriptions to The Comix Method: Resources automatically renew unless canceled before the next billing date.

4. Access and Certification

Access to course materials and certification status is contingent on timely payments.

If any payment fails or is not received, access to the program may be suspended until payment is resolved.

Failure to complete all scheduled payments will result in revocation of certification, loss of access to ongoing or future resources, and forfeiture of any progress or materials received.

5. Refund Policy

Due to the digital and educational nature of these programs, no refunds are available once enrollment is processed, whether paid in full or through a payment plan.

6. Ownership and Use

All digital content provided through The Comix Method is the intellectual property of The Comix Method and is protected by copyright law. Access to these materials is granted solely for personal study and classroom instructional use by the enrolled educator or verified staff of the registered studio. Materials may not be reproduced, shared, redistributed, or resold in any form.

The Comix Method content may not be used for the purpose of developing or teaching independent certification programs, teacher-training courses, or judging/educator education seminars. Use of these materials for any business, competition, or educational activity intended to generate revenue or replicate The Comix Method curriculum is strictly prohibited without written permission from The Comix Method.

7. The Studio Unlimited Policy

The Studio Unlimited Certification grants a single studio location unlimited staff registration for The Comix Method Certification for a period of three (3) years from the date of enrollment.

During this term, any number of current staff members may complete certification and utilize the Resources subscription.

After the initial 3-year period, studios may continue to maintain certification status for previously certified educators at no additional cost. However, any new staff members added to the program beyond that period will be subject to an access fee of \$199 per educator, which grants full certification access for each additional participant.

Once certification is complete, any new staff member may access their Comix Method: Resources materials as long as the registered business maintains an active subscription with The Comix Method: Resources (free for one year following first staff certification, and 50% discounted annually thereafter).

Separation from employment forfeits course and resource access, and the registered owner of the course may request removal of a staff member at any time.

This policy is intended to provide studios with flexible access to train their current team while ensuring fairness and sustainability for future program participation.
